


**CITY OF QUINCY, ILLINOIS ORGANIZATIONAL CHART AS TO
OFFICES AND DEPARTMENT FOR FREEDOM OF INFORMATION REQUESTS
2016-2017**



1. SUMMARY OF PURPOSE: PROVIDES THE FOLLOWING SERVICES OR FACILITIES: POLICE AND FIRE PROTECTION; CONSTRUCTION, MAINTENANCE AND REPAIR OF STREETS, BRIDGE AND PUBLIC PARKING LOTS; SEWAGE DISPOSAL AND GARBAGE COLLECTION; PROVIDES AND MAINTAINS WATER SUPPLY; ISSUES BUILDING, PLUMBING AND ELECTRICAL PERMITS AND ENFORCES ZONING AND BUILDING CODE ORDINANCES; MAINTAINS AIRPORT FACILITIES; PROVIDES PUBLIC BUS SERVICE; PROVIDES PUBLIC LIBRARY. THE LEGAL DEPARTMENT IS LEGAL ADVISOR TO ALL CITY OFFICES AND PROSECUTES ORDINANCE VIOLATIONS. THE MAYOR IS THE CHIEF EXECUTIVE OFFICER OF THE CITY. THE CITY COUNCIL IS THE LEGISLATIVE DIVISION OF THE CITY. THE CITY CLERK IS THE RECORDKEEPER FOR THE CITY AND ISSUES ALL REQUIRED LICENSES. THE CITY TREASURER RECEIVES, INVESTS AND DISPENSES CITY FUNDS. THE COMPTROLLER SUPERVISES RECEIPT, COLLECTION, OR DISBURSEMENT OF CITY REVENUE AND RECORDS IN REGARD TO SAME.
2. THE AMOUNT OF THE OPERATING & CAPITAL BUDGET FOR THE CITY OF QUINCY FOR FISCAL 2016-2017 IS \$35,910,050.00.
3. THE NUMBER OF FULL-TIME EMPLOYEES WAS 297 AT THE COMMENCEMENT OF FISCAL 2016-2017.
4. THE FOLLOWING ALDERMANIC COMMITTEES EXIST: AERONAUTICS, BARGE DOCK, CENTRAL SERVICES, CITY HALL, FINANCE, FIRE, HISTORIC PRESERVATION, HOMELAND SECURITY, HUMAN RIGHTS, LIBRARY, LOAN, PERSONNEL, PLAN COMMISSION, PLANNING AND DEVELOPMENT, POLICE, SAFETY, STREET LIGHTS/RIGHT-OF-WAY, TECHNOLOGY, TOWN BOARD, TRAFFIC COMMISSION, TRANSIT ADVISORY, UTILITIES, AND 9-1-1. OTHER COMMISSIONS ARE BUILDING COMMISSION, ELECTRICAL COMMISSION, ENTERPRISE ZONE BOARD, POLICE AND FIRE COMMISSION, WASHINGTON THEATER COMMISSION AND ZONING BOARD OF APPEALS. THE NAMES AND ADDRESSES OF MEMBERS OF EACH SAID COMMITTEES CAN BE PROCURED FROM THE CITY CLERK'S OFFICE, 730 MAINE STREET, QUINCY, ILLINOIS.
5. THE LOCATION OF EACH OFFICE IS AS STATED IN THE ABOVE ORGANIZATIONAL CHART.
6. PLEASE DIRECT ALL REQUESTS FOR PUBLIC DOCUMENTS TO THE CITY'S FOIA OFFICER LOCATED IN CITY HALL. REQUESTS CAN BE MADE FROM 8:30 A.M. TO 4:30 P.M. ON MONDAY THROUGH FRIDAY, EXCEPT HOLIDAYS.
