OFFICIAL PROCEEDINGS

REGULAR MEETING

Quincy, Illinois, October 21, 2024

The regular meeting of the City Council was held this day at 7:00 p.m. with Mayor Michael A. Troup presiding.

The following members were physically present: Ald. Fletcher, Bergman, Bauer, Hultz, Mays, Sassen, Rein, Ebbing, Reis, Reed, Uzelac, Holtschlag. 12.

Absent: Ald. Entrup, Farha. 2.

Ald. Bergman moved the absent Aldermen be excused and allowed the usual compensation for this meeting. Motion carried.

Ald. Bergman moved to amend the October 15, 2024 minutes, concerning the 48th & State Resolution #1. The amendment should show that Ald. Ebbing did not vote nay on the first vote to accept option #1 and the vote to adopt the resolution as amended. It should show that Ald. Reis voted nay on both votes. Motion carried.

The minutes of the regular meeting of the City Council held October 15, 2024, as amended, were approved on a motion of Ald. Bergman. Motion carried.

PUBLIC COMMENTS

Briana Rivera, Director of The District, invited everyone to The Districts Trick or Treat event on October 26th. Ernest Hicks surrendered his three minutes.

Donna Allen wanted to know how many knew what the vote would be ahead of the vote for the roundabout last week. Jack Freiburg stated that St. Boniface Catholic Church has historic and architecture significance.

Richard Vogel stated that removing the stoplights from 25th & Broadway would make it difficult for pedestrians crossing Broadway.

Barry Cheyne spoke about the Friends of Justice program.

Terrell Dempsey read a letter from Tony Crain asking to take serious consideration of the St. Boniface Catholic Church landmark designation.

Randy McElhoe stated that the roundabout would open up a line of traffic that does not stop.

Matthew Thomas Messier stated that St. Boniface Catholic Church is part of a unique American story and is sacred to the Catholics.

Wills Nixon stated that the round about at 48th & State is not wanted and read of statement from the president of Illinois of Ayerco stating it would be detrimental to his business.

Steve Homan stated that the roundabout is a waste of money, and the Aldermen did not listen to the people in their ward.

Jackie Erwin asked why there is a need for no parking on the east side of South 6th Street between State and Kentucky Streets.

Recommending the referral to implement a "No Parking" zone on the east side of South 6th Street between State and Kentucky Streets be granted.

Ald. Uzelac moved the report be received and concurred in and an ordinance drafted. Motion carried.

Ald. Mays moved for the adoption of the ordinance, seconded by Ald. Hultz, and on a roll call each of the 12 Aldermen voted yea, with 2 absent.

The Chair, Mayor Michael A. Troup, declared the motion carried and the ordinance adopted.
