- **8a.** Special Event Application requesting permission to hold the annual St. Peters Parish Picnic on Friday, August 22nd and Saturday, August 23rd between the hours of 4:00 pm. and 12:00 a.m. (midnight) at 2600 Maine Street with live music until 12:00 a.m. (midnight).
