8. Petitions:

8a. By the following organizations requesting permission to conduct a raffle and have the bond requirement waived: ABWA Quincy Charter Chapter from February 10, 2026, through April 25, 2026; and The Quincy Landlords Rental Association from February 10, 2026, to February 9, 2027. The City Clerk recommends approval of the permits.

8b. By Quincy Brewing Company, 110 N 6th St, requesting a quarterly Live Entertainment/Public Gathering license from April 4, 2026, through June 27, 2026 for live music Saturdays in their outdoor patio area from 7pm-9pm. The Quincy Police Department have approved the application. **Ward 7**

8c. A petition from Sherry Hills to vacate approximately 4,150 square feet of an east-west public alley (197-feet by 20-feet) located south of 1123 N 4th St to allow for the establishment of the southern property line for 1123 N 4th St. **Zoned C1B, Ward 1**

9. Reports of Plan Commission:

9a. Recommending approval and an ordinance drafted for a Special Permit for Planned Development to allow for the operation of an adult day care facility at 1220 Broadway Street with the following conditions: 1) that an ingress/egress agreement be required between the owners of 1200 Broadway Street and 1220 Broadway Street and 2) that if the parking area south of 1220 Broadway Street is developed as a courtyard area with privacy fencing, a parking agreement must be in place between the owners of 1200 Broadway Street and 1220 Broadway Street. **Ward 7**

9b. Recommending approval and an ordinance drafted for a Special Permit for Planned Development to allow for the demolition of two existing buildings at 2126 South 12th Street and for the construction of two new buildings at 2126 South 12th Street as part of the operation of a landscaping business with following conditions: 1) that this Special Permit for Planned Development is non-transferrable and 2) to allow for the construction of an accessory building that is 70' x 35' (2,450 square feet) and to allow for the construction of an accessory building that is 70' x 40' (2,800 square feet) at 2126 South 12th Street. **Outside City Limits, near Ward 6**
