  - 3) \$3.25 per each additional opening.

#### Residential Fee Structure:

Building Wiring: (Fee equals the sum of paragraph A)

- A) 50 volts-120 volts wiring openings:
- 1) 3 to 40 openings minimum charge of \$40.00
  - 2) 240 volts up to 2 openings, minimum charge of \$40.00
  - 3) \$1.00 per each additional opening.

**HOMEOWNER APPLYING FOR PERMIT (SINGLE FAMILY DWELLING ONLY).** City of Quincy Code Section 54.03 (C) requires all electrical work must be performed by a licensed electrical contractor. The only exception to this is that a homeowner may do electrical work in their own residence, provided that they intend to reside there for one year after work is completed. Section 115.16 (A). **ALL** electric service entrance equipment must be installed by a licensed electrical **contractor**.

Upon completion of all work, Inspection Department shall be notified two days before concealment. Section 54.07.
